## THE CORPORATION OF THE MUNICIPALITY OF WEST ELGIN BY-LAW NO. 2012-10

A BY-LAW TO AMEND BY-LAW NO. 98-47 BEING A BY-LAW REQUIRING OWNERS TO FENCE PRIVATELY OWNED SWIMMING POOLS

WHEREAS Section 7 of the Building Code Act, R.S.O. 1990, c.B.13, as amended, empowers municipalities to pass by-laws respecting building permits and the issuance thereof;

AND WHEREAS Section 11(3) of the Municipal Act, 2001, S.O. 2001, c.25, as amended, provides that a lower-tier municipality may pass by-laws respecting matters within the spheres of jurisdiction including but not limited to structures, including fences and signs;

AND WHEREAS it is deemed necessary to require fencing of above ground pools in certain circumstances;

NOW THEREFORE the Municipal Council of the Municipality of West Elgin ENACTS AS FOLLOWS:

1. That By-law 98-47 be amended by adding the following section:

SECTION 5A - ABOVE-GROUND SWIMMING POOLS

Section 5 does not apply to an above-ground pool if the pool compiles with the following standards:

- (i) The pool wall shall be equal or greater than 1.2 metres above grade;
- (ii) A guard not less than one metre high is provided around any platform or deck:
- (iii) The outside of the swimming pool structure and any guard is free of any element or attachment that may facilitate climbing;
- (iv) No part of the swimming pool structure is closer than 1.2 metres to any lot line: and
- (v) The point where a user of the above-ground pool gains access to the pool is protected by a gated enclosure which complies with the requirements for swimming pool fences as set out in Section 5 inclusive.
- 2. That Schedule "A" of By-law 98-47 is hereby deleted.
- 3. That Schedule "A", "Application for Swimming Pool Enclosure Permit", attached hereto and forming parting of this by-law, is hereby adopted.
- 4. That fees for swimming pool enclosure permit shall be in accordance with the Fees and Charges By-law Building, as amended from time to time.
- 5. That this by-law shall come into force and effect upon final passing thereof.
